

## **LONE STAR BEER FLAGS OF TEXAS INDEPENDENCE T-SHIRT OFFER TERMS**

### **OFFER ENDS 5/31/09**

1. **Eligibility.** Participation is open only to individuals who are legal residents of Texas, who are at least twenty one (21) years of age as of the date of participation.
